Reporting to the Chief Executive Officer, the officer will be responsible for branding and development of communication strategy, policies and plans. The officer will also be responsible for:

- (i) Overseeing development, implementation and review of communication strategies, programs and policies;
- (ii) Publicizing the organization's activities;
- (iii) Editing and production of the organization's newsletters, magazines and brochures;
- (iv) Coordinating development and management of information, education and communication materials;
- (v) Managing Media Information Service;
- (vi) Facilitating press conferences, official functions, visits, seminars, workshops, public relations exhibitions and other organizational social events;
- (vii) Preparing speeches, briefs, press supplements, press statements, news releases and feature articles;
- (viii) Collaborating with media houses for coverage of the organization's events;
